Classes I to XII (Non-DAE wards):

Admission fee : 100/- (once while seeking admission)

Tuition fee : 1500/- per month PUVVN fee : 300/- per month

Computer fee : 30/- per month for Classes I to X

: 50/- per month for Computer Science students of Classes XI

and XII

Term fee : 50/- For six months
Internal Examination fee : 50/- For six months
Library deposits : 100/- For six months

Laboratory deposits: 200/- For six months(only for Science students)

Late fee of Rs 50 will be charged from all defaulters.

Exemptions:

- (#) SEEP Students are exempted from payment of fees.
- (#) All girl students whose parents are below poverty line shall be exempted from payment of Tution Fee alone (Subject to submission of a valid certificate issued by a competent authority)
- (#) All students belonging to SC/ST whose parents are below poverty line shall be exempted from payment of Tution Fee alone (Subject to submission of a valid certificate issued by a competent authority)
- (#) The wards of Central Government employee whose third child is a girl student are exempted from payment of Tution Fee alone and also in respect of the third child

onwards of SC/ST employees of Central Government subject to furnishing of an undertaking/Declaration.

(#) All students whose parents combined annual income is less than 2.5 lakhs/annum are granted fee concession to the extent of 50% of revised Tution Fee for Non DAE students but not less than Rs. 900/month, subject to submission of valid certificate. (This is applicable only to those Non DAE students who have taken admission in AECS till the academic year 2017-18)
