**Admission Notice ( for DAE wards only )**

**AECS, Narora is inviting application form for admission in class-III for the session 2025-2026 of wards of DAE only.**

**Eligible students studying in class-II ( 2024-25) may apply at the earliest.**

**Guidelines for admission of DAE ward to Class- III for the academic session 2025-2026**

**1. Eligibility :**

- i) Children of employees of the DAE secretariat, Constituent Unit, Project, Aided Institutes, and Public Sector Undertakings under full control of Department of Atomic Energy (DAE) are eligible for admission in Atomic Energy Central School, Narora. All such children will be considered as DAE wards. In case of resignation or removal of employees working in DAE and its Constituent Unit from their service, and if they want to continue their children in AECS, Narora, they have to pay the fees at the rates charged for the Non-DAE wards from the date of exit from their services.
- ii) The admission to the wards of CISF employees and others for whom specific approval of AEES/ DAE exists would be considered at par with the DAE wards as long as the employee concerned continues to work in DAE units. The wards of such employees will be charged fee at par with the wards of DAE employees. This concession ceases once the employee leaves DAE or its Constituent Units. If the CISF employee on his transfer out of DAE Units wants to continue their ward(s) in the schools of AEES, the employee has to pay the fee at the rate charged for the Non-DAE wards.
- iii) Children of DAE employees who have superannuated or have expired/passed away while in service or who have become invalidated while in service will be treated at par with DAE wards for admission.
- iv) The admission to the wards of Intelligence Bureau employees working in liaison units of DAE would be treated at par with DAE ward as long as the IB employee continues to work in liaison unit of DAE. This concession ceases once the IB employee leaves DAE or its Constituent Unit. If an IB Employee on his transfer out of DAE Unit wants to continue their ward(s) in the schools of AEES, the employee has to pay the fee at the rate charged for the Non-DAE wards.

**2. Age criteria for admission :**

The minimum and maximum age limit for admission in AEC Schools in various classes is given below: ( **Note: The child born on 1<sup>st</sup> April should also be considered.**)

Class	Minimum age on 31 <sup>st</sup> March, 2025 of the year in which admission is sought	Maximum age on 31 <sup>st</sup> March, 2025 of the year in which admission is sought
III	8 Years	10 Years

**3. Procedure for submission of application forms for admission:**

Admission form for admission can also be procured from the office of AECS Narora by paying an application Fee of rupees 100/-. Online through at SB Collect of AEC School website

OR

Application form for admission can be downloaded from the website of AEES. The duly filled in form along with an application fee of rupees 100/- should be submitted to the AECS, Narora.
