Subject: Admission Circular for Non-DAE categories for the session 2026-2027.

Applications are invited for admission under the Non-DAE categories, for the vacant seats as notified below. All non-DAE admissions in AECS, Narora will be made from Balvatika-I onwards. Non-DAE wards (ND-4 to ND-1 categories) at AECS, Narora are allowed to apply for admission against the vacant seats in Classes, I, II, III, IV, V, VI and VII (Vacancy in Balvatika-I may arise ) as given below:

**Please note that admission under Non-DAE category (ND-1 to ND-4) is not assured as it depends on available vacancies in the respective classes and approval from AEES, Mumbai.**

The minimum and maximum age limit for admission in AECS, Narora in various classes is given below: (Child born on 1<sup>st</sup> April should also be considered )

**(a) Eligibility under Non-DAE Categories:**

Priority categories of Non-DAE wards for seeking admission in the school against the vacant seats will be as follows for the session 2026-27.

Category Code	Description
ND-4	Wards of people residing around DAE establishment.
ND-2	Wards of Central /State Government/PSU employees engaged in DAE activities and / or working for the DAE (e.g. Sausheelya, Mehatva, School for Special Children, Co-operative Credit Society, Banks, Post Office NAPP Narora etc.), and the wards of the employees of contractors working for DAE Projects and Wards of the Defence / Paramilitary Personnel or Wards of their widows.
ND-3	Grandchildren of serving/retired or expired DAE employees (One admission per employee) Grandchildren of AEES employees (Serving/retired or expired) shall be given preference.
ND-1	Wards of the Project Affected People (PAP), whose land has been acquired for the DAE project

**Definition of neighborhood:** The residence of the applicant should be within a radius of 8 km. from AECS, Narora.

**Note: Non-DAE admissions under ND-4 to ND-1 categories will be considered, subject to the availability of seats and approval of AEES.**

**Applicants under all categories of Non-DAE must produce the following two certificates at the time of obtaining application forms from the school office:**

1. Photocopy of any valid document establishing the relationship of the child with the applicant (such as Ration card, Aadhar card, Birth certificate etc.).
2. A self declaration in writing, with regard to the distance of the residence from AECS, Narora

**Admission form under Non-DAE categories can be downloaded from the school website. Admission form fee Rs 100/- should be deposited through online SBI collect. The payment receipt of SBI collect must be submitted with the application form.**

**Note: "Contractors"** refers to those contractors who have been awarded a current work order for a period of a year or more (Specific period to be mentioned).

**Additional document to be submitted along with the filled-in application form for "Non-DAE categories":**

In the case of wards of central Govt. / State Govt. / PSU employees / employees of contractors applying under ND-2 category, the duly filled-in application form has to be submitted to the school authorities after obtaining the counter signature of the administrative authorities of local DAE unit.

**Additional document to be submitted at the time of admission:**

Those seeking admission to any class from Standard II onwards will be required to submit a valid and original Transfer Certificate (TC) from the school last attended, as per the guidelines issued by CBSE, Delhi.

**Method of selection and criteria to be applied:**

If the number of applications is more than the seats available, the admission to: Balvatika-I, classes I, II, III, IV, V, VI & VII will be based on lottery.

It may please be noted that the following criteria will be applied in distributing students under the Non-DAE categories:

If the seats are fewer than four, they will be distributed in the order of the categories.

If the seats are more than four, each category will be allotted an equal number of seats to the extent possible. The remaining seats will be redistributed among 'other Non-DAE categories', according to the order of priority. If there are very few or no applicants to a particular category / categories, the seats allotted to that particular category/ categories will be redistributed among other Non-DAE categories, according to the order of priority, in the manner described above.

**General:**

- Applicants and their parents may please note that AECS, Narora is an English-medium co-educational school.
- Please note that admission is not assured, it is subject to approval by AEES, Mumbai. Therefore parents are advised to explore other avenues also and not to be exclusively dependent on admission to AECS Narora.
- If the Non-DAE candidate getting the opportunity of admission after approval from AEES, Mumbai and fails to take admission on due date, then no opportunity will be provided to other candidates and the seat will remain vacant for next year. i.e. No waitlist / opportunity for admission to other candidates.
- If the required documents are not submitted along with the application (unless otherwise indicated), the application will be rejected.
- Parents can ask for admission form for another ward also even if their wards are studying in any class.
- Admission will be granted on the basis of the promotion class and fulfillment of eligibility criteria. (e.g. a child must have passed and promoted from class II to get admission in class III). The same must be reflected in UDISE Portal.
- Parents will be allow to apply for admission only under one category of Non-DAE and only in one class.

: 4 :

All the remaining criteria for admissions will be based on the guidelines of AEES, as applicable from time to time. The duly filled-in Application Forms should be submitted at the school office (secondary section, AECS, Narora).


